

# Admissions Arrangements for Meon Junior School for the 2026-2027 school year.



## Introductory statement

Meon Junior School is a 7-11 Junior School, coeducational, non-selective academy, part of the Thinking Schools Academy Trust.

### Published Admission Number (PAN)

The school has an admission number of **90** for Year 3. It will admit this number of pupils if there are sufficient applications. If fewer than **90** applications are received, all applicants will be offered a place. If more than 90 applications are received, the oversubscription criteria below will be used to determine which applicants can be offered a place.

### Main admissions round application process

Admissions to the School are part of the co-ordinated admissions scheme of Portsmouth City Council. Parents wishing to apply for a place should put the school down as a preference on the common application form. Applications for year R must be submitted via the Portsmouth City Council website by the national closing date of 15 January 2026. Late applications will be processed by Portsmouth City Council.

### In-year admissions process

In-year school admissions for the whole school will be dealt with by the Portsmouth City Council. Information on how to complete an in-year admission are available on the council's website ([In-year applications - Portsmouth City Council](#)) and this will be processed by Portsmouth City Council's Admissions Team. If your child is already on role with us and you wish to transfer to another school, you will need to complete this form ([In-year application Portsmouth School transfer form](#)) and bring it in to be stamped by the team. Parents who do not have access to the internet, can request a hard copy form via the school office.

### Oversubscription criteria

The school will admit any pupil with an Education, Health and Care plan which names the school. Priority will then be given to children who meet the criteria set out below, in order.

1. Looked after children and previously looked after children (for definitions, see notes below)
2. Children who have an exceptional medical or social need that means there is a significant need for them to attend this school rather than another e.g. if it is their nearest school and they have an illness which means it would be extremely difficult for them to travel to a further school. Children who have an exceptional social or medical need which means they should attend this school rather than any other or whose parents have such a need. Your application must be supported by evidence, for example from a medical specialist or social worker, of the [child's/parent's] need and why it means the child needs to attend this school. Applications that are submitted without supporting evidence cannot be considered under this criterion.
3. Siblings (for definitions of siblings – see notes below) - Siblings of pupils who at the time of admission have a sibling attending the school or our linked schools, Meon Infant or Moorings Way Infant School.
4. Children who attend the following infant schools that are part of the Thinking Schools Academy Trust namely Moorings Way Infant School, Meon Infant School and Penbridge Infant School. If the school cannot admit all children from the named feeder infant schools, applicants will be ranked within this category in accordance with priorities 5,6,7.
5. Priority will next be given to children of staff at the School, in either of the following circumstances:
  - a) The member of staff has been employed at the School for two or more years at the time at which the application for admission to the school is made, or
  - b) The member of staff is recruited to fill a vacant post for which there is a demonstrable skill shortage
6. Children living within the School's designated catchment area. (If the School cannot admit all applications from the catchment area, applicants will be ranked within this category in accordance with priorities in 7. below.

7. Children living outside the School's catchment area in the following priority order:

*i.* Children eligible for service premium

*Note - service premium is paid to eligible children of armed services personnel under S14 of the Education Act 2002*

*ii.* Children who live closest to the School, based on the shortest distance from home to school, measured on straight line 'as the crow flies'. (This distance will be used where necessary to prioritise applications).

Note: Should the School be oversubscribed from within any of the criteria above then any additional criteria will be used to prioritise applications within these categories. In priority order as listed above.

#### Tie-break

If a tie-break is necessary for distance, random allocation will be used to determine which child will be offered a place. This will be verified by someone independent from the school who will conduct the random allocation.

#### Multiple Birth Siblings

The infant class size rules allow schools to exceed the limit of 30 pupils per teacher when children from a multiple birth are tied for the final place.

Random allocation will not be used if siblings from a multiple birth (twins, triplets etc.) are tied for a place. They will all be offered a place and we will exceed our admission number.

#### Delayed admission to reception

Parents who are offered a place for their child in the reception class may defer the date they are admitted, or arrange for them to attend part-time, until they reach compulsory school age. Places cannot be deferred

beyond the beginning of the final term of the school year for which the offer was made.

Children reach compulsory school age on the prescribed day following their fifth birthday, or on their fifth birthday if it falls on a prescribed day. The prescribed days are 31 August, 31 December and 31 March.

#### Admission of children outside their chronological age group

Parents may request their child is admitted outside their normal age group. Parents who wish to do so should make their request to the school, specifying the year group to which they wish their child to be admitted and why they believe it would be in their best interests.

The academy trust will make a decision on the basis of the circumstances of the case and whether it may be in the child's best interests, taking into account the views of the headteacher and any information provided by the parent. The school will notify parents of the decision and set out clearly for the parent the reasons for their decision.

Parents who are unhappy with the decision in respect of an application out of chronological age group can make a complaint about that decision in accordance with the school's complaints policy.

#### Admission of summer-born children

Parents who wish to delay entry and start in year R a year later rather than year 1 for their summer born child should make their request alongside their Starting School application with any evidence and reasons. These are co-ordinated by the LA but the decision will be made by the Academy Trust. If agreed the Starting School application will be withdrawn and parents will be invited to apply the following year.

#### Waiting list

All parents who have been refused a place at the School will have the option to indicate their wish to remain on the waiting list. Children will be

held on the waiting list by order of the criteria in the Admissions Policy. No account can be taken of the length of time a pupil is on the list. A pupil's position can change on the list as new applicants join or other applicants come off the waiting list.

The list will be re-ranked each time another child is added to the list.

### Appeals

If a parent is unsuccessful with any of their preferences, they will have the right of appeal to an independent appeal panel and will be provided with the relevant documentation and advice by the LA's Admissions Team.

### Monitoring Arrangements

Whenever changes to admission arrangements are proposed (except where the change is an increase to the agreed admission number), the Board will publicly consult on these changes. If nothing changes, it will publicly consult on the School's admission arrangements at least once every 7 years.
